



## WAJI “MAJIC MONEY MACHINE RULES”

### 1. How to Enter the Contest:

a. The contest will begin on November 19, 2024, at 11:00am and end on December 31, 2025, at 12:35pm. Each Money Machine contest will last for 95 minutes.

- a. To enter, participants must text a specific keyword on display at the registration table during the designated Majic Money Machine appearance to (260)-467-9500. Message and data rates may apply based on the mobile provider and are the responsibility of the participant. Contestants are required to submit their name and email address along with phone number to submit a keyword and become a member of the text club to participate in the contest.
- b. To be eligible participants must have a mobile device with an active texting service and internet or cellular connection to register and it is the responsibility of the contestant to provide to participate.
- c. Complete and submit the entry, including your first and last name, telephone number and a valid e-mail address. Online entrants are subject to all notices posted online including but not limited to the station's privacy policy as described at <http://www.majic951.com>.
- d. One entry per person during each Majic Money Machine appearance.
- e. A contestant may only enter by texting the keyword regardless of the entrant having more than one phone or email address. Multiple participants are not permitted to share the same phone number or email address. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest administrator. By the use of Studio Texter operated by Envisionwise, LLC, contestants agree to Station’s website user agreement and privacy policy as described on at <http://www.studiostexter.com>.
- f. Entries will be deemed to be made by the authorized account holder of the phone number and data account with a service provider submitted at the time of entry. The authorized account holder is the natural person who is assigned to the phone number by a phone service provider, or other organization that is responsible by assigning phone numbers and accounts associated with the submitted text messages.
- g. All entries must be received before the final contest episode at each Majic Money Machine appearance to be eligible. Failure to provide the required information may result in disqualification.
- h. No purchase necessary.

## **2. Eligibility Restrictions:**

a. You must be 18 years of age or older with a valid photo I.D. or other identification issued by the U. S. government or an educational institution. To enter and be eligible to win, you must live in the Fort Wayne metropolitan area, consisting of Adams, Allen, Dekalb, Huntington, Noble, Steuben, Wells and Whitley Counties in Indiana. Employees of Sarkes Tarzian Inc., ProFed Credit Union and radio stations in the Fort Wayne Metro, and members of their respective families are not eligible. Family is defined as parents, in-laws, children, spouses, people in spouse-like relationships and siblings, including those in step and half relations. Anyone who has been employed by or interned with Sarkes Tarzian, Inc., is also ineligible.

b. Persons who have won prizes of cash or merchandise totaling \$600 or more from WAJI since May 19, 2024, are ineligible for this contest.

## **3. Prizes:**

a. Each Grand Prize has been assigned an undisclosed random number between 1 to 95. The starting value is \$951.00. To be a winner contestants must match the number on their Fake Money captured during the time in the Majic Money Machine with the number of the Grand Prize. Once a contestant exits the Money Machine a comparison is made to determine if a match has occurred, and a winner or loser is revealed. This process will continue until there is a Grand Prize winner or 6 contestants have played. If there is no winner at the end of 6 contestants during a Majic Money Machine appearance \$95.00 will be added to the Grand Prize total value. Once there is a winner the contest is over for that appearance and the Grand Prize total will return to \$951.00 at the start of the next Money Machine contest appearance.

b. The Grand Prize must be claimed in person at the offices of WAJI, 1005 Production Road, Fort Wayne, IN 46808. The winner will forfeit any prize not claimed within 30 days of winning. Any prize or prize certificate not claimed within 30 days of winning will be forfeited by the winner. If the prize is forfeited, it will remain the property of WAJI.

c. Up to 6 consolation prizes to be awarded during each Money Machine appearance. Each prize is a Majic Money Machine, a T-shirt valued at approximately \$7.00. Shirts are awarded to any participant that does not make a match and wins the Grand Prize.

d. Each of the 6 randomly selected contestants will have 9 seconds in the Majic Money Machine to catch a piece of fake money or paper money. A station representative will be the official timekeeper in the contest.

1. Contestants cannot use clothes to catch the money, including shirts, coats, pants, dresses or any other apparel.

2. Fake money cannot be grabbed off the floor, ceiling or pinned against the sides of the Money Machine.

3. Only hands and arms may be used to grab the fake money in the Money Machine.

4. There will be a total of 95 individually numbered pieces of paper or fake money in the Money Machine at the time of each contest episode.

5. The Money Machine will be emptied with the fake money and the 95 individual pieces checked and counted after each contest episode or when a station representative deems necessary.

6. Each contestant will have one attempt inside the Money Machine.

7. Any participant that does not follow contest rules and regulations may be disqualified at the sole discretion of station management and will not will a prize amount.

e. Contestants must catch at least one piece of fake money while in the money machine to be eligible for the Grand Prize.

f. Odds of winning the Grand Prize are 1 in 95 if a participant catches one piece of fake money.

g. If a contestant catches more than one piece of fake money while inside the Money Machine, that participant must choose which fake piece of money they wish to attempt to match the number associated with the Grand Prize. If the number on the fake money matches the number of that day's Grand Prize, the contestant will win the Grand Prize. If a contestant's fake money does not match the Grand Prize number, the contestant receives a consolation prize. If a contestant does not catch any fake money during their time in the Money Machine, they will receive a consolation prize.

h. Contest prizes are not transferable.

Only the winner may claim the prize.

#### **4. Selection of Winners:**

a. Six contestants will be randomly selected from all eligible entries received, one every 15 minutes to participate. Each name will be announced promptly following the drawing. If a contestant does not present themselves within five (5) minutes of the first announcement regardless of the reason, the station reserves the right, but not the obligation, to disqualify that selected participant and select the next participant until the previous participant comes forward with five minutes of being announced. The process will continue until all 6 participants have been determined and are present to participate.

b. Entrants must be present at the respective Majic Money Machine appearance to enter.

c. The odds of being selected as a participant depend on the number of eligible on-site entries received at the time of each random drawing.

d. Station management decisions with respect to the contest are final.

#### **5. Conditions:**

a. Payment of all federal, state and local taxes is the sole responsibility of the winner. Winners will be reported to the IRS-on-IRS Form 1099 or the equivalent.

b. By participating in the contest, the winner or winners (and their guest or traveling companion, if any) agree to allow their name, voice, and/or likeness to be used in any advertising or broadcasting material relating to this contest for a period of one year without additional financial or other compensation.

c. All participants are required to sign a release of liability before entering the Majic Money Machine. Pursuant to the Liability Release, the winners will agree to hold WAJI, Sarkes Tarzian, Inc., ProFed Credit Union, and the respective officers, shareholders, directors,

employees, agents and representatives of each of them harmless from and against any and all claims or liability arising directly or indirectly from the prize or participation in the contest.

6. These rules are subject to the interpretation of WAJI. Any aspect of these rules, including the substitution of a prize or prizes of equivalent or greater value, can be changed at the discretion of WAJI, and such change(s) will become effective upon on-air or other appropriate announcement.

7. The contest is void where prohibited.

8. Failure to comply with the contest rules may result in a contestant's disqualification, at the sole discretion of WAJI.

9. WAJI is not responsible for typographical or other errors in the printing, the offering or the administration of the contest or in the announcement of any prize.
